PLAYER ENDORSEMENTS – PROHIBITED COMPANIES

NFL Players are prohibited from being a party to any endorsement arrangement of any kind with a company associated with the production, manufacture, or distribution of a substance that has been banned by the Policy on Performance-Enhancing Substances (*i.e.* any “Prohibited Substance” listed in Appendix A of the NFL’s Policy on Performance Enhancing Substances). This prohibition applies to any endorsement contract or similar arrangement with a company where one of the purposes of the arrangement is to endorse or promote (1) products that contain a Prohibited Substance; (2) supplement or similar sports nutrition brands that market or sell a product containing a Prohibited Substance (even if the product being directly endorsed or promoted does not contain a Prohibited Substance) and (3) retailers that primarily sell supplements and/or health food products (*e.g.* GNC, Vitamin Shoppe) and sell at least one product containing a Prohibited Substance. The prohibition also applies to any other company associated with the production, manufacture, or distribution of Prohibited Substances.

Players should consult the list of Prohibited Companies below prior to executing any endorsement arrangement to ensure compliance with the policy. These companies, which are identified below by the “Brands” and “Retailers” they own, constitute Prohibited Companies for purposes of this policy.

Unlike medications approved by the U.S. Food and Drug Administration (FDA), dietary supplements are regulated in a post-market manner and the FDA does not analyze the safety, efficacy, or label accuracy of supplements before they are sold to consumers. It is a certainty that there are companies not on the list below that are also associated with the production, manufacture, or distribution of Prohibited Substances.

Players should also consult the U.S. Anti-Doping Agency (USADA)’s Supplement 411 High Risk Dietary Supplement List which is available at <http://www.supplement411.org/hrl/> and the Operation Supplement Safety (OPSS) High Risk Supplement List which is available at <http://www.supplement411.org/opss/highrisklist.html>. Both are credible sources and frequently updated.

Players are further strongly encouraged to include the following clause (or a substantial equivalent) in any endorsement arrangement confirming that the company does not and does not plan to produce, manufacture or distribute a Prohibited Substance and allowing cancellation should circumstances change:

[Company] warrants that as of the date of execution of this agreement, it does not and does not plan to manufacture, sell or distribute any product containing a substance currently banned under the NFL's Performance-Enhancing Substances policy. The parties to this agreement acknowledge that a condition of Player's performance of the obligations set forth herein is that such performance will not require Player to violate the Policy on Performance-Enhancing Substances or other NFL policies. The parties agree that if the Commissioner of the NFL or his designee judges that Player's performance of this agreement has violated or would violate such policies, Player is excused from further performance of this agreement, and, if and as applicable, his compensation under this agreement shall be adjusted proportionately.
